1.	Identification of stray dogs:- The committee decided to identify the new stray dogs entered into the campus so that they may be pushed back out from the campus territory. Prof. Gargi Singh will help in identifying the new dogs with in coming four days	Prof. Gargi Singh & Security Officer
2.	Putting of collar belt: The present stray dogs should be put on neck collar so that new stray dogs could be identified. Prof. Gargi Singh will provide collar belt and help in putting the same to stray dogs or at the earliest.	Prof. Gargi Singh & Security Officer
3.	Identification of places –The campus residents are to be aware about the places when and where stray dogs are not to be fed. A notification is to be sent to the residents, through e-mail.	Prof. Gargi Singh & Security Officer




4.	Concentration of dogs: it is noticed that many dogs are visible close to construction site (opp. Maths/Physics Deptt.), as workers are residing there. Institute Engineer is requested to instruct the NBCC/CPWD authority.	Institute Engineer
5.	Feeding of stray dogs inside hostel: ADOSW (B/M) has advised to instruct the students that no pet/stray dogs are permitted inside the hostels and feeding of the dogs is also not to be done. This has to be maintained as per guide lines as specified in Para 3.	ADOSW (Bhawan/Mess)
6.	ABC programme: Next phase of sterilization and vaccination is to be held in the month of May 2019, due to new security team is taking over charge w.e.f 01 st May 2019. The Institute has entered into agreement with new security agency to take this task on priority in the first week of may 2019.	Security Office


